Dear Governor Wolf:

The Conservation and Natural Resources Advisory Council (CNRAC) is pleased to present its 2019-2020 annual report of our activities in fulfillment of our obligations to provide advice and recommendations to the Department of Conservation and Natural Resources (DCNR).

CNRAC continues to closely follow issues that impact the programs and services of DCNR. The challenges presented by this year's pandemic were many, and CNRAC recognizes and appreciates the extraordinary efforts of DCNR staff to meet those challenges. As the impacts of the pandemic increased, state parks saw exponential growth in visitation, with some parks experiencing more than a 100% increase over the previous year. CNRAC appreciates your recognition of the importance of outdoor recreation on the physical and mental health of the citizens we serve. Outdoor recreation is an enormous, vital industry in Pennsylvania, generating \$29.1 billion annually in consumer spending and sustaining a quarter of a million direct Pennsylvania jobs.

Along with these significant increased demands for recreational opportunities, habitat loss, invasive species, gas leasing and other pressures continue to consume financial and human resources. From the presentations by DCNR staff throughout the year, we know that these limited resources have the potential to affect DCNR's ability to fully carry out its mission. We urge you and the legislature to continue to protect the agency's special funds and to dedicate more of the state's General Fund to the operational budget of the agency. We look forward to working with DCNR, your office and legislators on the challenging issue of the backlog of more than \$1 billion in parks and forests infrastructure needs.

CNRAC continued to actively participate in the development of strategic plans, policies and programs for state parks and forests, outdoor recreation, and motorized recreation. We are excited about the possibility of creative and innovative programs to continue to serve current users of our parks and forests and to encourage new users to take advantage of these unique resources. CNRAC has established a new Diversity, Equity and Inclusion Work Group to devote expertise and time to working alongside DCNR staff to develop goals to increase access and develop relevant activities to ensure all citizens have opportunities to enjoy our parks and forests.

We are excited to begin to see the strategic plans implemented and are committed to continuing to work with your office and DCNR staff to ensure the Commonwealth's natural resources are protected while offering vital recreational opportunities to our citizens.



#### **CNRAC WORK GROUPS**

CNRAC Work Groups continued to meet and discuss current issues to provide input and recommendations to DCNR. In 2020, CNRAC established a new Work Group—the Diversity, Equity and Inclusion Work Group, to reflect a key priority of DCNR. Membership of each Work Group and highlights of activities for the past year are summarized below.

Motorized Recreation Work Group Bob Kirchner, Rocco Ali, Gary Kribbs, Stock Illoway

In 2019, the Motorized Recreation Work Group published a report with 15 recommendations regarding expanding motorized recreation opportunities in Pennsylvania, including the growing demand for ATV riding opportunities. Since publication of the report, the Work Group has had discussions with DCNR on its recommendations and provided reports to CNRAC on the status of each recommendation. In March 2020, the Work Group reviewed the proposed changes to DCNR's ATV Trail Development and Management Policy; changes to the policy were one of the Work Group's recommendations in its 2019 report. The Work Group is awaiting DCNR's responses to the many comments received by DCNR on the proposed changes.

#### **Strategic Planning Work Group**

The Strategic Planning Work Group reviewed the Statewide Comprehensive Outdoor Recreation Plan and developed comments. The Work Group also reviewed the state parks strategic plan, *Penn's Parks for All,* and the priorities for the upcoming Bureau of Forestry strategic plan and provided comments. The Work Group will continue to monitor updates to these planning documents and assist with the implementation of the final plans.

# Communications and Outreach Work Group Sarah Hall-Bagdonas, Gary Kribbs, Greg Goldman, Geralyn Singer (Cliff David, appointment ended in January 2020)

The Communications and Outreach Work Group continued to monitor relevant legislation and met with leaders of the Senate and House Environmental and Energy Resources Committees to keep legislators informed of CNRAC activities and viewpoints. The Work Group continued its work with DCNR staff on updates to the CNRAC website with meeting minutes and Council reports/letters. The Work Group also continued to grow its stakeholder list to maintain communication and notify interested groups and citizens of CNRAC meetings. Council also responded to several questions/comments submitted by citizens through the website.

# Diversity, Equity and Inclusion Work Group Joanne Kilgour, Janet Sweeney, Geralyn Singer, Greg Goldman, Steve Stroman

In 2020, CNRAC formed a new Diversity, Equity and Inclusion Work Group to support DCNR's objectives in this area, following a presentation at its January 2020 meeting by Ms. Emily Hendrickson, DCNR's new DEI coordinator. The group is establishing its priorities and goals for the next year, including frequent discussions at CNRAC meetings.

# Infrastructure Work Group Stock Illoway, Geralyn Singer, Gary Kribbs, Janet Sweeney, Dave Trimpey (Ephraim Zimmerman and Bill Forrey, appointments ended January 2020)

DCNR manages and maintains more infrastructure than most state agencies. Maintenance encompasses a wide range of activities and investments—routine maintenance, preventative maintenance, and corrective maintenance. Maintaining infrastructure requires funding for staff and materials, as well as engineering and other contracted services. Unfortunately, the money required for maintenance has not kept pace with the needs. The Infrastructure Work Group continued to focus on and highlight the tremendous funding need for infrastructure upgrades and maintenance at state parks and forests, now totaling more than \$1 billion. The needed investments range from bridges to wastewater treatment facilities, dams and invasive plant removal, and from roads to trails. The Work Group continued to monitor proposed legislation and discuss the needs with legislators. The Work Group is partnering with the Pennsylvania Parks and Forests Foundation in their outreach efforts, as well as initiating CNRAC communications and outreach activities.

## Penn's Parks for All Strategic Plan Draft Paul Zeph, Bureau of State Parks

Mr. Zeph highlighted sections of the draft strategic plan for state parks, including data collection and recommendations. He reviewed the activities underway for obtaining public comment and input on the draft plan and invited CNRAC members to assist with the outreach. CNRAC members provided initial observations and comments about the draft plan.

# 2019-2020 DCNR Enacted Budget Stacie Amsler, Bureau of Administrative Services

Ms. Amsler provided an overview of the 2019-2020 DCNR enacted budget and showed a three-year comparison of major operating appropriations. She advised of all the general funds collected in the commonwealth; DCNR's share is 35% of each penny or \$.0035 of the dollars collected. She explained the different funding sources that go into the budget, with the General Fund and Oil and Gas Lease Fund providing much of the operating revenue, and park user fees, federal funds, and timber sales augmenting these funds.

## Land and Water Conservation Fund Conversions Tom Ford, Bureau of Recreation and Conservation

Mr. Ford gave an overview of the Land and Water Conservation Fund and how DCNR directs the funding down to local recreation and conservation projects. He noted that more than 1,600 projects have been completed with these funds in Pennsylvania, since the program began over 50 years ago. The Bureau of Recreation and Conservation staff inspect about 20% of the sites each year to ensure that lands funded by LWCF are not converted to non-recreation uses.

#### **PUBLIC COMMENT**

Mr. Patrick Henderson, Marcellus Shale Coalition, gave Council an update on the impact fee in Pennsylvania.

Mr. John Childe inquired about how the Bureau of State Parks and Bureau of Forestry are coordinating their strategic planning efforts and encouraged better integration of the two bureaus on important issues.

#### **OCTOBER 2, 2019 FIELD TRIP**

### **Bald Eagle State Park**

CNRAC held its October 2, 2019 meeting at Bald Eagle State Park. The Council invited numerous stakeholder groups to attend the meeting and participate in small group discussions on the recommendations of the draft *Penn's Parks For All* strategic plan.

Prior to the meeting, Council members met with the park manager, Mike Winters, and toured several areas of the park to see firsthand unique park features, as well as infrastructure needs. From the Nature Inn to the unlimited horsepower boating, 369-slip marina, and newly built Environmental Learning Center, Council members experienced some of the distinctive attributes of the park, which are used by more than 550,000 visitors each year.



Mr. Winters highlighted a few of the infrastructure needs including modernizing water and sewer systems, buildings, and park roads. Such modernization will reduce emergency repairs and continue to enhance the visitor experience. He also reviewed with the Council staffing challenges and visitors' changing expectations for camping venues and technology.

As part of their public portion of the meeting, council members and



public attendees received an overview of the *Penn's Parks For All* strategic plan by DCNR's Paul Zeph. Council members then worked with the stakeholder organizations in small groups to discuss the strategic plan's recommendations. The Council used the input from the stakeholders as it prepared its own comments and suggestions on the plan.

## Conserving Penn's Woods, Bureau of Forestry Strategic Plan Ryan Szuch, Bureau of Forestry

Mr. Szuch discussed the Bureau's strategic plan, Conserving Penn's Woods, which is in the early stages of development. He noted the timeline for the plan is development in 2020, following by organizational alignment, which will take a few years. Mr. Szuch provided a handout of the draft list of priorities and requested the Council's feedback on the priorities. He noted once a draft plan is available, it will be provided to Council for review and comments.

Proposed Revised ATV Policy
John Norbeck, DCNR Deputy Secretary for Parks and Forestry
Nicole Faraguna, DCNR Policy Director

Mr. Norbeck and Ms. Faraguna reviewed the history of Pennsylvania's ATV policy and provided background on DCNR's ATV trail system and grant program. They presented on the environmental and enforcement challenges that resulted in an ATV Trail Moratorium in 2001 on any new trails on DCNR lands. The growing demand from the public for long-distance trails and connections between communities is driving proposed changes they presented in a revised ATV policy. Ms. Faraguna stated the changes would rescind the 2003 moratorium and permits DCNR to explore opportunities for new trails/connectors on state forest lands, while continuing to prohibit ATV trails in state parks. Ms. Faraguna said DCNR is looking at increased ATV usage as an opportunity to help ATV users have a stronger stewardship connection by establishing a network of stewardship leaders within the ATV community. DCNR is looking to the ATV community and industry for help in developing this stewardship connection.

# DCNR's Diversity, Equity and Inclusion Initiative Emily Hendrickson, DCNR DEI Coordinator

Ms. Emily Hendrickson presented on DCNR's new Diversity, Equity and Inclusion Initiative to help improve the agency's demographics, and she was hired as the coordinator for DCNR's DEI efforts. She stated 1,500 employees were trained on diversity, and an employee mentor program was launched to increase inclusion with new employees. She added that an action plan has been prepared, and DEI is becoming a conversation in all the agency's work.

#### **PUBLIC COMMENT**

Public comments at this meeting focused on the proposed changes to the ATV policy and are summarized below:

- Jerry Walls, Pine Creek Watershed Council/Pennsylvania Wilds Land Use: Mr. Walls expressed
  appreciation for CNRAC working on issues and considerations to fulfill DCNR's responsibilities under
  the Pennsylvania Constitution. He said the Watershed Council is not opposed to ATV trails so long as
  they are in the appropriate locations, but expressed concerns about funding and possible impact on
  streams.
- Cindy Barrick, PA State Snowmobile Association, Region 10 Director: Ms. Barrick said her
  association also is not opposed to ATV trails and focused her comments on proper maintenance of
  existing and new trails, and concern that snowmobile use may be impacted by increased ATV use.
   She also expressed interest in knowing how associations can work with DCNR to help maintain the
  roads including the use of volunteers.
- Eric Bruggeman, PA Off-Highway Vehicle Association: Mr. Bruggeman commended DCNR for the
  proposed changes and thanked Council member Bob Kirchner on the motorized recreation report.
  Mr. Bruggeman said the Association believes the proposed changes will help balance the demand
  for off-road recreation and provide a great way to get people outdoors who do not always have the
  means for accessible recreation.
- Steve Salisbury, American Motorcyclist Association: Mr. Salisbury said he was pleased to hear about the out-of-state research being done and encouraged DCNR to have a dedicated staff person for the off-road programs with appropriate authority. His comments focused on funding issues a concern that Pennsylvania does not currently register off-road motorcycles.
- **Jim Laird, DCNR Trails Advisory Committee:** As the off-highway motorcycle representative on the Trails Advisory Committee, Mr. Laird stated Pennsylvania has a good opportunity to capture Canadian recreational users, in addition to the increasing number of ATV users in Pennsylvania. Mr. Laird said there are also many unregistered ATVs which could be contributing through registration fees. He also expressed his belief that this type of recreational use provided a great opportunity for cross-generational participation, as well as accommodation and inclusion.

# Proposed Revised DCNR ATV Policy Nicole Faraguna, DCNR Policy Director

Ms. Faraguna gave the status of the proposed revised draft ATV policy, which was released on January 27 for a 60-day comment period. Ms. Faraguna said approximately 75% of the comments were supportive of the changes, with 25% indicating some concerns or overall opposition. She noted DCNR will be balancing the public comments with other survey and polling data more representative of all of Pennsylvania. Ms. Faraguna advised the next steps include preparing a response to comments document by the late summer, adapting the policy as needed, and having a final policy in early to mid-fall.

# DCNR's Operations of State Parks and Forests During the Pandemic John Norbeck, DCNR Deputy Secretary for Parks and Forestry

Mr. Norbeck reviewed the status of parks during the pandemic, noting the evolving changes needed to respond to conditions, while prioritizing the need to provide outdoor recreation as an essential part of maintaining a healthy lifestyle. He covered the challenges of managing all aspects of the agency, but particularly dealing with the record visitation state parks and forests were experiencing. With increased usage came a significant amount of illegal ATV use, an increase in graffiti and trash, and other illegal activity from visitors not familiar with the rules and regulations of these public lands.
