STONE SALES ON STATE FOREST LAND

- Hand collection of stone is the only method of collection permitted on state forest land.
- Stone collected under this permit is intended for personal use only. The re-sale of any stone is strictly prohibited and punishable by law.
- Loose stone is sold at \$5.00 per ton plus applicable sales tax, Pennsylvania sales tax is 6%.
- Permits issued are required to be for a minimum of 2 tons, and a maximum of 10 tons.
- The maximum allowable cumulative tonnage of all permits issued to any one person in a given calendar year is 10 tons.
- Term of the permit shall not exceed 30 days, regardless of tonnage purchased.
- The specific location for collection must be established before permit is issued and properly noted on the permit. No more than 2 locations are permitted on any one permit.

Stop in the office for a permit, or detach and mail the application and payment to the district office.

Do NOT mail your application sooner than 7 days prior to anticipated collection date

IT IS RECOMMENDED THAT YOU SCOUT A SPECIFIC LOCATION FOR STONE BEFORE APPLYING FOR A PERMIT

A NOTE TO THE PERMITTEE

Mountain Stone Permittee:

Mountain stone collection on state forest land is a privilege offered to all responsible citizens, 18 years of age or older, who are willing to adhere to the regulations necessary to protect our environment.

Experience has taught us that these few rules are necessary. By promptly reporting violators, you can help insure that our mountain stone program will be continued from year to year.

Please read the regulations carefully. Should you have any questions, contact our office by calling (814) 643-2340, email us at FD05@pa.gov, or writing to: Bureau of Forestry, 181 Rothrock Lane, Huntingdon, PA 16652. In case of an emergency or to report a violation after normal working hours contact the Huntingdon County Control Center (814-643-3960), the Centre County Control Center (1-800-479-0050), or the Mifflin County Control Center (717-248-9607) and ask the person on duty to contact one of our forest officers who will return your call as soon as possible.

May your mountain stone collecting and your time spent on Rothrock State Forest be an enjoyable experience.





STONE SALES ON STATE FOREST LAND

- Collection of any foundation stone to include old cabin, home, and barn foundations is prohibited.
- Collection of any river rock, stream cobble, bank stone, or other rock material from a stream, stream channel, stream bed, stream bank, or other stream feature is prohibited.
- Collection of rock within the riparian buffer of 100 feet from the stream bank edge is prohibited.
- Collection of stone from areas that contain rattlesnake dens, rattlesnake basking areas, woodrat habitat, wetlands, or any other ecologically sensitive area is prohibited.
- Collection of bridge abutment stone, culvert headwall and tailwall stone, deer fence base stone, or road or stockpiled stone is prohibited.
- NO mountain stone collection is permitted in Natural Areas, Wild Areas, or any area posted against stone collection.
- Mountain stone collection is prohibited along Route 322, 26, and 305. It is also prohibited along Charter Oak Road and Barree Road, and Grissinger Camp Lane.
- The following roads are CLOSED for removal of mountain stone:

Bear Meadows Road Bear Gap Road Diamond Valley Road Trough Creek Drive

- Vehicles are not permitted off of maintained forest roads.
- If you see someone violating rules, please report it to a forestry employee.
- Forest Officers will be patrolling. Violations of any state forest rule or regulation may result in a fine of up to \$300 and suspension of permit.
- A permit is valid for collection of loose stone ONLY.
- Loose stone is stone that rests on, and is taken from, a surface or slope on state forest land, that does not lie in a mechanically excavated pit and is collectable by hand.
